21. Future Advances. Upon request of Borrower, Lender, at its option, may make Future Advances to Borrower. Such advances shall be made in accordance with the terms of this Mortgage, when evidenced by promissory notes stating that same are payable to Lender. At such time as the principal amount of the indebtedness secured by this Mortgage, plus interest thereon, exceeds \$10,000.00, Lender may thereafter make such advances to protect the security of this Mortgage, except the amount of such advances shall not exceed \$10,000.00.

22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage, or any part thereof, shall be void, and Lender shall release this Mortgage upon delivery to Borrower, Borrower's heirs, executors or administrators, if any.

23. Waiver of Homestead. Borrower hereby waives all right of homestead against the Property.
