8. The Minister further agrees that he will take such steps as may be necessary under the National Housing Act within 12 months of the date of this Agreement to cause the Department of Housing and Urban Development to issue a final report on the development dated subsequent to the date of this Agreement. The Minister further agrees that he will cause the report to be made available to the House of Commons at the earliest opportunity and that he will, if he so desires, make the report available to the Senate. The Minister further agrees that he will cause the report to be made available to the public at the earliest opportunity.

It is agreed that the Mortgagor shall hold up to the amount of \$10,000.00, and pay over to the Trustee, for the mortgage on the note secured hereby. It is further agreed, that the Mortgagor shall fully perform all the terms, conditions and covenants of this instrument, and that if he fails to do this, the mortgage shall be strictly null and void, after notice to the Mortgagor of such failure. It is further agreed, that all the terms, conditions, covenants of this instrument, shall be binding upon the heirs, executors, administrators, and successors of the Mortgagor, and that the Mortgagor shall remain personally liable upon the Mortgagery, till sons then owing to the Mortgagor the Mortgagor shall be entitled to sue him, and that this mortgage can best be sued. The Mortgagor waives the right to sue in the courts of the State of South Carolina. Should any legal proceedings be instituted for the fore sale of this or the security of the Mortgagery, he or a party to it, or a witness, being his attorney or trustee, shall be allowed to add to the debt secured hereby, a sum just thereof be placed in the hands of an attorney at law, to collect the same, otherwise all costs and expenses including collection and attorney fees allowed by the Mortgagor, and a reasonable attorney's fee, shall thereupon become due and payable to such attorney, as a part of the debt of the Mortgagor, as a part of the debt secured hereby, and may be recovered as a debt due and payable.

The covenants herein contained shall bind, and the benefits and obligations hereunder shall inure to the benefit of the heirs, executors, administrators, successors, and assigns of the parties hereto. All expenses of the administration hereunder shall include the principal, the interest, the principal, and the costs of collection, attorney's fees, and other expenses.
