SEND GREETING

WHEREAS, we the said Thomas G. Smith, Jr. and Doreann L. Smith
in and by certain promissory note in writing, hereinafter called the "Note"

due and payable on the 5th day of each and every calendar month thereafter until paid in full, with interest and all costs, insurance and expenses incurred in collecting the same, and to make payments to be applied first to the payment of interest and then to the cost of collection, expenses and attorney's fees, if any, incurred, and said note further providing that if at any time any part of the principal or interest due hereunder shall be past due and unpaid for a period of six (6) months, or if at any time any part of the principal or interest due hereunder shall be past due and unpaid for a period of six (6) months, and as a result thereof, any of the by-laws of said Association, or with any of the stipulations of the Note, or the Note becomes due under said Note, shall at the option of the holder become immediately due and payable, and no further notice for a reasonable attorney's fee besides all costs and expenses of collection will be given; the amount due on said Note and attorney's fees, if any, to be paid with an attorney fee, shall be paid and collected, and if there be, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS That we the said Thomas G. Smith, Jr.
and Doreann L. Smith, do hereby mortgage to the said Citizens Building and Loan Association,
Greer, S. C., the land described in the Note, and further sum of Three \$300
Dollars to the said Note, and we and they, and truly paid by the said mortgagors, at and
before the sealing and delivery of these presents, for which, and in consideration whereof, have mortgaged, hereinafter
sold and released, and by these presents do grant, hold, bind and release unto the said Citizens Building and
Loan Association, Greer, S. C., its successors and assigns.

That certain lot, part or tract of land, with all improvements now constructed thereon, or hereafter
constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick
Springs Township, on the east side of Pine Street Extension in the City of Greer,

J. O. Burnett, by H. S. Brockman, Registered Surveyor, dated June 11, 1941, recorded
