At such time shall the principal amount of the indebtedness so given by this Mortgage, and any interest thereon, be paid over and delivered to protect the security of this Mortgage, except the original amount of the Note up to \$8,

**22. Release.** Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recording, if any.

**23. Waiver of Homestead.** Borrower hereby waives all right of homestead exemption in the Property.
