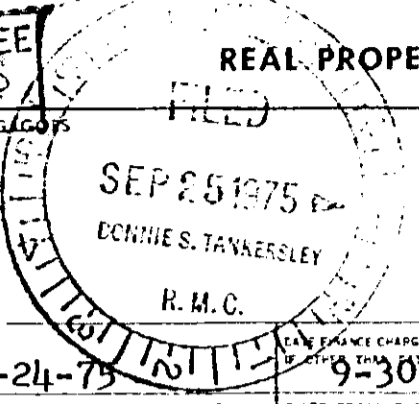

NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, on the northerly side of Woodville-Pelzer Road and having according to a plat prepared by Carolina Engineering and Surveying Company, September 16, 1969, and recorded in the R.M.C. Office for Greenville County in Plat Book _____, page _____, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Woodville-Pelzer Road in line of property now or formerly of Scott and running thence N. 11-0 W. 382.2 feet to an iron pin; thence S. 69-0 E. 27 1/2 feet to an iron pin; thence S. 76-30 E. 100 feet to an iron pin; thence S. 15-50 E. 128 feet, more or less, to a point in the center of Woodville-Pelzer Road S. 7 1/2-10 W. 150 feet to the point of beginning.

TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagee, its successors and assigns forever.

If Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, liens, assessments, obligations, prior encumbrances, and any charges whatsoever against the above described real estate as they become due. Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to Mortgagee in Mortgagee's favor.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
