MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly included unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty-five Thou-

sand Nine Hundred Nine and 54/100 -----(\$ 25,909.54--)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain -----a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

WHEREAS, said note further provides that if at any time only portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said helder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of cellecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose:

NOW, KNOW ALL MEN. That the Mortgager, in consideration of said debt and to secure the payment thereof and any further sums which may be a lyanged by the Mortgager to the Mortgager's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgager in hard well and tridy paid by the Mortgager at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgager, its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that piece, parcel or lot of land, with improvements thereon, situate lying and being on the southern side of Emily Lane in the County of Green-ville, State of South Carolina and known and designated as Lot No. 8 according to a plat entitled "Moonville Realty" recorded in the R.M.C. Office for Greenville County in Plat Book 4W at Page 10 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 7 and 8 and running thence S. 7-54 E., 230 feet to an iron pin at the joint rear corner of said lots; running thence S. 82-06 W., 110 feet to an iron pin; running thence N. 7-54 W., 210 feet to a point; running thence N. 37-06 E., 35.4 feet to an iron pin on Emily Lane; running thence with said lane N. 82-06 E., 90 feet to the point of beginning.
