ESTEMNO at an Iron pin at the southeastern corner of the intersection of Ivydale Drive (formerly Churchill Avenue) and Sanders Lane and running thence with Ivydale Prive S. 52-47 E. 96.8 ft. to an iron pin at the southwestern corner of the intersection of Ivydale Drive and a Mo-foot street; thence in a southerly direction with the western side of said Mo-foot street to an iron pin at the northwestern corner of Lot 155; thence with the line of Lot 155 S. M3-07 W. 185 ft. to an iron pin; thence N. 66-0 W. 60 ft. to an iron pin; thence S. 24-0 W. 175 ft. to an iron pin on the northern side of Morty Ridge Prive (formerly Eisenbower Street), joint front corner of Lots Nos. 63 and 6h; thence with the northern side of Mofty Ridge Prive N. 62-50 W. 172 ft. to an iron pin at the northeastern corner of the intersection of Mofty Ridge Drive and Sanders Lane; thence with the eastern side of Sanders Lane N. 26-41 E. 165.3 ft. to an iron pin; thence continuing with Sanders Lane in a northerly direction to an iron pin at the southeastern corner of the intersection of Ivydale Brive and Sanders Lane which is the point of teginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagoe and all persons whomsoever lawfully claiming the same or any part thereof.
