"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Greenwood Avenue near the city of Greenville being shown and designated as Lot No. 51 on plat of Hudson Acres prepared by Woodward Eng. and Construction Co. & T. C. Hill Associates dated June, 1950, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book Y at Page 39 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Greenwood Avenue at the joint corner of Lot Nos. 51 and 52 and running thence along and with the joint property line of said two lots, S. 29-50 W. 146 feet to an iron pin; thence S. 58-00 E. 148.9 feet to an iron pin at the joint corner of Lot Nos. 50 and 51; thence running along and with the northern side of Greenwood Avenue, N. 51-00 E. 175 feet to an iron pin; thence continuing along the curve of Greenwood Avenue, the chord of which is N. 24-45 W. 23 feet and N. 30-30 W. 25 feet to an iron pin; thence running along and with the northern side of Greenwood Avenue N. 75-15 W. 195 feet to the beginning.
