(4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises. (6) That the covenants herein contained shall bind, and the benefits and advantages shall inute to, the respective heirs, executors, administrators successors and assigns, of the parties hereto.
