- 2 That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums
  - An amount sufficient to provide the holder here of with funds to pay the next mortgage insurance premium if this instrument and the note socured hereto are insured, or a monthly charge oin lieu of a mortgage insurance premium; if they are held by the Secretars of Housing and Urban Development, as follows:

Action on controller to accumulate in the hands of the holder one (I) nonth prior to its due date the onnual northage incoration premium in order to provide such holder with funds to put such premium to the Secretary of Housing and Urban Development pursuant to the National Housing Act, as amended, and applicable Regulations thereunder, or
  - (II) It and so I he as said in to of even date and this instrument are held by the Secretary of Housing and Urban Devel pronto a monthly charge on lieu of a mortgage insurance promount which shall be in an amount equal to one-to-clith (I 12) (fone-halt (I)) per centum of the average outstanding balance due on the note computed without taking into account delinquencies or prepayments.

That he will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and in default thereof the Mortgagee may pay the same, and that he will promptly deliver the official receipts therefor to the Mortgagee. If the Mortgagor fails to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the Mortgagee may pay the same, and all sums so paid shall to a interest at the rate set forth in the note secured hereby from the date of such advance and shall be secured by this mortgage.
- 5. That he will keep the premises in as good order and condition as they are now and will not commit or permit any waste thereof, reasonable wear and tear excepted.

That he will keep the improvements new existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and other hazards, casualties and contingenties in such amounts and for such periods as may be required by the Mortgagee and will pay promptly, when due any profittems on such insurance provision for payment of which has not been made hereinbefore. All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have altached thereto loss payable clauses in favor of and in form acceptable to the Mortgagee.
