Minus to an iron pin; thence continuing N. 75° 45' E. for a distance of Forty (40') feet along Parcel B. to an iron pin; thence turning and running S. 200 oo' E. for a distance of One Hundred Seventyfive (1751) feet along property of E. R. Hinus to an iron pin; thence turning S. 750 45' W. for a distance of Three Hundred (300') feet along property designated as Holliday Hill Subdivision to the iron at the point of commencement. Beginning at an iron pin in the Southwesternmost corner where said tract intersects with property of E. R. Hinus and right of way of Holliday Road and running N. 680 45' W., for a distance of Two Hundred Minety-Nine and 9/10 (299.9') feet along property of E. R.
