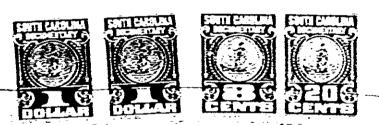

TO HAVE AND TO HOLD all and singular the said bads and premises unto Lender, its successors and assigns with all the rights, privileges, members and appartenances thereto belonging or in any wise appertaining.

UNDERSIGNED hereby binds himself, his heirs, executors, administrators and assigns to warrant and forever defend all and singular the said premises unto Lender, its successors and assigns, from and against Undersigned, his heirs, executors, administrators and assigns and all other persons whomsoever hawfully chiming or to chim the same or any part thereof.
