in accordance with Borrower's and Lender's written agreement or applicable law. Borrower shall pay the amount of all morteage in surance premiums in the manner provided under paragraph 2 hereof.

Any amounts disbursed by Lender pursuant to this paragraph 7, with interest thereon, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree to other terms of payment, such amounts shall be payable upon notice from Lender to Borrower requesting payment thereof, and shall bear interest from the date of disbursement at the rate payable from time to time on outstanding principal under the Note unless payment of interest at such rate would be contrary to applicable law, in which event such amounts shall bear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph 7 shall require Lender to incur any expense or take any action hereunder.

- 8. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

- 12. Remedies Cumulative. All remedies provided in this Mongage are distinct and cumulative to any other right or remedy under this Montgage or afforded by law or equity, and may be exercised concurrently, independently or successively.
- 13. Successors and Assions Bound; Joint and Several Liaettity; Captions. The covenants and agreements herein contained shall bind, and the rights hereunder shall inute to the respective successors and assigns of Lender and Bottower, subject to the provisions of paragraph 17 hereof. All covenants and agreements of Bottower shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
