The Marigagor further covenants and agraes as follows

- (1) That this mortgage shall secure the Mortgages for such fur that sums as may be advanced hereafter, at the option of the Moragages, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
