"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 94 on plat of Gray Fox Run made by C. O. Riddle, Surveyor, dated November 6, 1975 and recorded in the RMC Office for Greenville County in Plat Book 5P at Page 9, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Gray Fox Square at the joint corner of Lots 93 and 94 and runs thence along the line of Lot 93, N. 30-51 W. 190.2 feet to an iron pin in the center of Cane Creek; thence along center of said Creek, as the property line, the traverse line being S. 78-18 W. 120.2 feet to an iron pin in the center of said Creek; thence S. 7-56 W. 55.4 feet to an iron pin; thence along the line of Lot 95, S. 48-43 E. 209.7 feet to an iron pin on the North side of Gray Fox Square; thence with the curve of Gray Fox Square (the chord being N. 50-13 E. 85 feet) to an iron pin, the beginning corner.
