NOW, KNOW ALL MEN, that Mortgagor (et. al. if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County, Greenville.

Beginning at an iron pin in the northwestern side of S. C. Highway 23-106 416 feet northeast from Canterbury Road at the corner of Lot 29 and running thence with the northeastern side of said Highway N. 59-11 W. 225 feet to an iron pin at the corner of Lot 27; thence with the line of said lot No. 30-16 E 225 feet to an iron pin in line of Lot 24; thence with the line of Lot 26 and Lot 40 S. 59-11 E 225 feet to an iron pin at the corner of Lot 29; thence with the line of said lot S 30-16 W 225 feet to the beginning corner.

Upon any default, all obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
