MORTGAGE OF REAL ESTATE

Whereas, Fred W. and Ruth Knebusch

of the County of Greenville, in the State aforesaid, hereinafter called the Mortgagor, is

Whereas, the Mortgagee, at its option, may hereafter make additional advances to the Mortgagor, or his successor in title, at any time before the cancellation of this mortgage, which additional advance(s) shall be evidenced by the Note(s) or Additional Advance Agreement(s) of the Mortgagor, shall bear such maturity date and other provisions as may be mutually agreeable, which additional advances, plus interest thereon, attorneys' fees and Court costs shall stand secured by this mortgage, the same as the original indebtedness, provided, however, that the total amount of existing indebtedness and future advances outstanding at any one time may not exceed the maximum principal amount of

Ten Thousand Three Hundred Twenty-Five & No/100 Dollars (\$ 10,325.00),
plus interest thereon, attorneys' fees and Court costs.

Now, Know All Men, the Mortgagor in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of One Dollar (\$1.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns the following described property:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina known and designated as the majority part of Lot #225 as shown in a plat of addition of South Forrest Estates, recorded in the R.M.C. Office for Greenville County in plat book EE at page 195, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Plainfield Circle, joint corner of Lots 224 and 225; thence along the joint line of said lots N. 37-24 E. 226 feet; thence S. 72-28 E. 73.5 feet; thence with the new line S. 2-55 E. 106.7 feet to an iron pin in the line of Lot 226; thence with the line of said lot S. 59-29 W. 178.9 feet to Plainfield Circle; thence with said Circle N. 55-32 W. 70 feet to the point of beginning.
