(herein "Borrower"), and the Mortgagee, GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 107 Church Street, Greer, South Carolina 29651 (herein "Lender").

Whereas, Borrower is indebted to Lender in the principal sum of Eight Thousand and to 100--
Dollars, which indebtedness is evidenced by Borrower's note dated May 20, 1976 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on May 1, 1986

Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the East side of Brockman Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 7 on plat of Property of C. C. freeman, made by Dalton & Neves, Engineers, actober, 1954, recorded in the MAD Office for Greenville County, South Carolina, in Plat Book N, Page 73, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Brockman Ivenue, at joint front corner of Lots 6 and 7, and running thence with the line of Lot 6, S. 78-53 E. 150 feet to an iron pin; thence 3. 10-11 V. 74 feet to an iron pin; thence N. 78-53 V. 150 feet to an iron pin on the East side of Brockman Ivenue; thence with the East side of Brockman Ivenue, N. 10-11 E. 75 feet to the beginning corner.
