MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagor) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ... Two. Hundred

Seventy-eight and 41/100------ (\$278.41) Dollars each on the first day of each month bereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortragor, or any stipulations set out in this mortrage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and papalle, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagon may hereafter become indeleted to the Mortgagor for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagos, in consideration of said debt and to secure the payment thereof and any further some which may be advanced by the Mortgagos to the Mortgagos's account, and also in consideration of the sum of Three Delians (\$3.00) to the Mortgagos in hand well and truly paid by the Mortgagos at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, burgamed, sold and released, and by these presents does grant, burgain, sell and release unto the Mortgagos, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of lend, with all improvements thereon, or hereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, on the northwestern side of Bangor Street in the Town of Mauldin, Greenville County, South Carolina, being shown and designated as lot no. 71 on a plat of Glendale, Section III, made by C. O. Riddle, Surveyor, dated April 1, 1974, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book 4-R, Page 83 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Bangor Street at the joint front corner of lots nos. 71 and 72 and running thence with the common line of said lots N. 45-00 W. 168.4 feet to an iron pin; thence S. 47-19 W. 110.1 feet to an iron pin at the joint rear corner of lots nos. 70 and 71; thence with the common line of said lots S. 45-00 E. 172.9 feet to an iron pin on the northwestern side of Bangor Street; thence with the northwestern side of Bangor Street N. 45-00 E. 110 feet to an iron pin, the point of beginning.
