To All Whom These Presents May Concern:

ROBERT H. JOHNSON and NANCY S. JOHNSON

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagor) in the full and just sum of

TWENTY-THREE THOUSAND AND NO/100 -----(\$ 23,000.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

(conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

ONE HUNDRED EIGHTY AND 95/100 ----- (\$180.95) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not soccue paid, to be due and payable.

All that certain power, pared, or lot of land, with all improves que thereon, or benedict to be construed the construed hing, and being in the State of South Carolina, County of Greenville, near the Town of Taylors, South Carolina, on the southeasterly corner of the intersection of East Heathwood Drive and Heathwood Drive being shown as Lot No. 59 on the Plat of Heathwood as recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book "EK", at Page 35 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Heathwood Drive, joint front corner of Lots Nos. 58 and 59 and running thence with the common line of said Lots S. 9-54 W. 209.2-feet to an iron pin; thence across the rear line of Lot No. 59 N. 80-06 W. 105-feet to an iron pin on the eastern side of Heathwood Drive; thence with said Drive 9-54 E. 177.7-feet to an iron pin at the southeastern corner of the intersection of Heathwood Drive and East Heathwood Drive; thence with the curve of said intersection, the chord being N. 57-12 E. 54.3-feet to a point on the southern side of East Heathwood Drive; thence with said Drive S. 75-29 E. 65.5-feet to an iron pin, the point of beginning.
