(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, known and designated as Lot No. 30 of ALTA VISTA, according to a plat by R. E. Dalton, Surveyor, and recorded in Plat Book G, page 20, of the R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:

east from the southeastern intersection of McDaniel Avenue and Cresent Avenue, and running thence with Cresent Avenue, S. 82-00 E. 74 feet to an iron pin, joint northern corner of Lots 30 and 31; thence with the joint line of said lots, S. 8-00 W. 200 feet to a 15-foot alley; thence across said alley 15 feet to an iron pin, joint southwestern intersection of line of Lot No. 33 and said alley; thence with the joint line of Lot No. 30 and 33, S. 8-00 W. 39.6 feet to an iron pin, joint southern corner of Lots Nos. 30 and 33; thence along the rear line of Lot No. 30, N. 73-09 W. 74.9 feet to an iron pin, joint southern corner of Lots Nos. 29 and 30; thence with the joint line of said lots, N. 8-00 E. 242.9 feet to an iron pin at the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagor agrees to pay to the mortgagee, annually, as premium for such coverage, 1/4 of 1% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
