All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Curtis Street, Town of Simpsonville, and being known and designated as Lot 2 of Property of F. M. Todd Estate, as shown on a plat thereof by W. J. Riddle, Surveyor, dated January 26, 1951, and being more commonly known as a part of the F. M. Todd Homeplace, said lot being situate on the Northwest corner of said Homeplace and having, according to the aforementioned plat, the following metes and bounds, to wit:
