All that piece, parcel or tract of land lying in the State of South Carolina, County of Greenville, Butler Township, near the City of Greenville, containing 7.05 acres, more or less, being shown on plat of "Property of Lucy M. Cunningham", prepared by R.K. C ampbell, December 9, 1959, and according to said plat being more fully described according to said plat as follows:

BEGINNING at an iron pin on the western side of Mitchell Road, which pin is 327 feet south of the corner of Property conveyed to Leland Cunningham by deed recorded in the RMC Office for Greenville County in Deed Book 512, at page 187 and running thence with the line of Mitchell Road, S. 34-55 E. 73 feet to a point; thence continuing with the western side of said Road, S. 0-22 W. 254 feet to a point; thence with the line of other property of the Mortgagor herein (passing through an iron pin 15.5 feet from said road) N. 86-00 W. 1072.5 feet to an iron pin in line of property now or formerly owned by Gibson; thence with the line of said property, N. 32 W. 252 feet to an iron pin at the rear corner of lot now or formerly owned by T. BEGINNING at an iron pin at the intersection of the right of way of Mitchell Road and a proposed Edgewood Road and running thence with the right of way of said proposed road, S. 89-59 W. 961.84 feet to an iron pin; thence N. 25-35 E. 20 feet to a stone; thence N. 30-15 W. 191 feet to an iron pin at corner of property now owned by the mortgagor herein; thence with the line of said property, S. 85-12 E. 1055.6 feet to an iron pin on right of way of Mitchell Road; thence with the western side of said right of way, S. 1-33 W. 94.3 feet to the point of beginning.
