That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 5 of 'a subdivision known as Valleybrook, Section I, as shown on a plat thereof prepared by R. B. Bruce dated November 24, 1971 and recorded in the R.M.C. Office for Greenville County, Plat Book 4 N, Page 60 and having, according to said plat, the following metes and bounds to-wit:
