(8) That the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors administrators successors and assigns, of the parties hereto. Whenever used, the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
