NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on Creighton Drive, known and designated as all of Lot No. 18, Section 3, Colonial Hills S/D, as shown on survey and plat recorded in RMC Office in Plat Book BBB at page 91, reference to said plat hereby pleaded for a more particular description, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at iron pin on edge of Creighton Drive and joint front corners of Lots 18 and 17, and runs thence as common line of said lots, S. 80-15 E. 160 feet to iron pin on line of Lot No. 142; thence with line of Lot No. 142 N. 59-45 E. 125.9 feet to iron pin on edge of street; thence with street, N. 86-33 W. 43.9 feet to iron pin on street; thence continuing N. 80-47 W. 91.5 feet to curve and intersection with Creighton Drive; thence around curve of intersection, the chord of which is S.54-29 W. 35.6 feet to edge of Creighton Drive; thence with Creighton Drive, S. 9-45 W. 95 feet to the beginning corner.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgager's amount and collect it as part of the debt secured by the mortgage.
