

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Richard R. Booms and Constance B. Booms

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of the first transfer referred to as Mortgagee.

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred Seventy-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying o and being in the State of South Carolina, County of Greenville, in O'Neal Township, containing 10.52 acres, more or less, as shown on plat prepared by Terry T. Dill, dated April 21, 1969, entitled "Property of Frank and Lucy C. Hall" recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-A, at page 183-A, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in Langley Road at corner of J. D. Anderson property and along said property N. 57-52 W. 178.5 feet to an iron pin; thence S. 89-08 W. 598 feet to iron pin at Creek and C. Styles property; thence N. 10-50 W. 320 feet along Creek to iron pin at corner of Grant and W. F. Case; thence along line of Case N. 47-15 E. 625 feet to iron pin at joint corner of this tract and an 8.10 acre tract as shown on said plat; thence S. 44-28 E. 423.1 feet to iron pin and continuing along said 8.10 acre tract S. 23=28 E. 500 feet to iron pin in Langley Road; thence along said Langley Road S. 66-30 W. 157.5 feet to the beginning corner, together with right of ingress and egress over the private dirve as shown on above mentioned plat.

This property is the same conveyed to the mortgagors by deed of H. Jerry Balding and Margaret V. Balding by deed dated December 19, 1976, recorded herewith.
