ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the Southwest corner of Pelzer and Ravenel Streets, and having according to survey of R. E. Dalton, May 1931, the following metes and bounds, to wit:

COMMENCING at an iron pin at the Southwest corner of Pelzer and Ravenel Streets and running thence along the West side of Pelzer Street, S. 6-00 W. 157.4 feet to an iron pin; thence along other property of Victor Monaghan Company, N. 83-00 W. 94.4 feet to an iron pin on the East side of an alley; thence along the East side of said alley, N. 7-00 E. 199.6 feet to iron pin on the South side of Ravenel Street; thence along South side of Ravenel Street, S. 58-20 E. 100.8 feet to the beginning corner.
