NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, being known and designated as Lot No. 76 and part of Lot No. 77, on plat entitled "Property of Howard Leopard", prepared by Dalton & Neves, Engineers, dated January, 1977, and recorded in the RMC Office for Greenville County, S. C., in Plat Book 6.A at Page 5 reference to said plat is hereby craved for a metes and bounds description.

Heretofore, Mortgagor mortgaged to Southern Bank & Trust Company Lot No. 76, as more fully appears in mortgage dated December 10, 1976 which is recorded in the RMC Office for Greenville County, S.C. in Mortgage Book 1385, at Page 39. By deed dated January 14, 1977, from Dee Smith Company, Inc., to Howard Leopard, recorded in the RMC Office for Greenville County, S. C., in Deed Book 1049, Page 907, Mortgagor acquired a portion of Lot No. 77 and is giving this mortgage as additional security for the above mentioned note.

Being the same property conveyed to Mortgagor herein by deed of Dee Smith Company, Inc., dated January 14, 1977 and recorded in the RMC Office for Greenville County, S. C. in Deed Book 1049, Page 707.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not the Mortgage debt, whether due or not.
