- 2. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums
 - An amount sufficient to provide the holder hereof with funds to pay the next mortgage insurance premium if this instrument and the note secured hereby are insured or a nonthly charge cin lieu of a mortgage insurance premium) if they are field by the Secretary of Housing and Urban Development, as follows:
 - (I) If and so long as said note of even date and this instrument are insured or are reinsured under the provisions of the National Housing Act, on an unit sufficient to accumulate in the hands of the holder one (I) month prior to its due date the annual mortgage inscrance gramium, in order to provide such holder with funds to pay such premium to the Secretary of Housing and Urban Development pursuant to the National Housing Act, as amended, and applicable Regulations thereunder, or
 - (II) It and so I me as said note of even date and this instrument are held by the Secretary of Housing and. Urban Devolupment, a menthly charge (in lieu of a mortgage insurance premium) which shall be in an amount equal to one-twelfth (I-12) of one half (I) per centum of the average outstanding balance due on the note computed without taking into account delinquencies or prepayments;

If there shall be a default under any of the provisions of this mortgage resulting in a public sale of the premises covered hereby, or if the property is otherwise acquired after default, the Mortgagee shall apply, at the time of the commencement of such proceedings, or at the time the property is otherwise acquired, the balance then remaining in the funds accumulated under (b) of paragraph 2 preceding, as a credit against the assount of principal then remaining unpaid under the note secured hereby, and shall properly adjust any payments which shall have been made under (4) of paragraph 2
