(hereinafter referred to as Mortgagor) SEND(S) GREETING:

(\$ 42,800,00----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot 118 of Dove Tree Sub-division, according to a plat entitled "Dove Tree" by Piedmont Engineers & Architects, recorded in the R.M.C. Office for Greenville County in Plat Book 4X at Page 23 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dove Tree Road at the joint front corner of Lots 118 and 117 and running thence with the line of Lot 117, N. 78-03 W. 145.1 feet to an iron pin at the joint rear corner of Lots 148 and 149, 117 and 118; thence with the line of Lot 148, S. 27-04 W. 128.2 feet to an iron pin; thence with the line of Lot 119, S. 76-04 E. 174.3 feet to an iron pin on the western side of Dove Tree Road; thence with the western side of Dove Tree Road, N. 13-51 E. 130 feet to an iron pin, the point of beginning.

BEING the same property conveyed to the Mortgagors herein by deed of W. N. Leslie, Inc., said deed being dated May 14, 1976, and recorded in the R.M.C. Office for Greenville County in Deed Book 1036 at Page 604.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
