All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 19 on Map. No. 1, Cunningham Acres, recorded in Plat Book BBB at page 118, and having such courses and distances as will appear by reference to said plat.

The carpet is included as a part of the mortgaged premises. Being the same property conveyed by Robert Dawson and Virginia C. Abrams to the mortgagors herein by deed recorded March 28, 1977.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned.
