Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

ALL that certain piece, parcel and lot of land with improvements thereon, situate, lying and being in the County of Greenville, State of South Carolina on the eastern side of Whir Court, and being known and designated as Lot No. 21 according to a plat of Whipporwill Hills, Section 2, prepared by Carolina Surveying Company, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book 4R at Page 39, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Whir Court at the joint front corner of Lots 21 and 22 and thence with the common line of said lots, N. 88-29 E. 164.7 feet to an iron pin; thence N. 0-51 E. 136.8 feet to an iron pin; thence N. 88-39 W. 220 feet to an iron pin; thence S. 0-33 E. 82.6 feet to a point on the northern side of Whir Court; thence with the curve of Whir Court, the chord of which is S. 67-10 E. 42.2 feet to a point on Whir Court; thence continuing with the curve of Whir Court, the chord of which is S. 16-07 E. 43.8 feet to the point of beginning.
