MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgager, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgager's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgager in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, on the southwestern side of Swinton Drive, being shown and designated as Lot No. 13 on a plat of Windsor Park made by R. K. Campbell, Surveyor, dated March 29, 1960 and recorded in the RMC Office for Greenville County, South Carolina in Plat Book RR, page 25 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Swinton Drive at the joint front corners of Lots Nos. 13 and 14 and running thence along said side of Swinton Drive, N. 30-15 W. 100 feet to an iron pin at the corner of Lot 12; thence along the line of said lot, S. 59-45 W. 180 feet to an iron pin; thence S. 30-15 E. 100 feet to an iron pin at the corner of Lot No. 14; thence along the line of said lot, N. 59-45 E. 180 feet to an iron pin, the point of beginning.

The above-described property is the same acquired by the Mortgagor by deed from James D. Sullivan dated April 27, 1977 and recorded on April 28, 1977 in Deed Volume 1055 at page 49, RMC Office for Greenville County, South Carolina.
