MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, ANNIE ALVERSON

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being a portion of Lot No. 3 on a Plat of the Property of J.D. Hood prepared by W. J. Riddle, June 12, 1952, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Gethsemane Drive at the joint front corner of Lots 2 and 3 and running thence with the common line of said lots, S. 13-38 W., 185 feet to a point; thence a new line through Lot 3, N. 79-00 W., 151.7 feet to an iron pin in the line of Lot 4; thence with the common line of Lots 3 and 4, N. 13-38 E., 185 feet to an iron pin on the South side of Gethsemane Drive, thence with said Drive, S. 79-00 E., 151.7 feet to the point of beginning, and being a portion of the property conveyed by deed recorded in Deed Book 706 at Page 508.
