WHEREAS, I the said Thomas W. Barnhill
hereinafter called Mortgagor, in and by my certain Note or obligation bearing

BEGINNING at an iron pin on the eastern side of Kenilworth Drive at the joint front corner of Lots 68 and 69 and running thence along the line of Lot 68, N. 80-0E. 175.0 feet to an iron pin; thence N. 10-0 W. 100.0 feet to an iron pin at the joint rear corner of Lots 69 and 70; thence along the line of Lot 70, S. 80-0 W. 175.0 feet to an iron pin on the eastern side of Kenilworth Drive; thence along Kenilworth Drive, S. 10-0 E. 100.0 feet to the beginning corner.
