20. Assignment of Rents; Appointment of Receiver. As additional security becomes, Baromer beneby assigns to Lender the rents of the Property, provided that B grower shall, price to acceleration under paragraph 18 hereof or aband nownt of the Property, have the right to collect and retain such rents as they become due and payable.
