MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

John W. Mulkey, Jr. and Linda D. Mulkey

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Six Thousand and No/100----- (\$ 6,000.00 _)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which rose does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Ninety-Six

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, Greenville Township, about four miles west of the City of Greenville, near the Old Easley Bridge Road, being known and designated as a portion of Lot No. 10 on a subdivision known as Avice Dale, plat of which is recorded in the RMC Office for Greenville County in Plat Book B at page 53, and having, according to a plat of the Property of Creatie S. Rothel made September 1, 1954 by Pickell and Pickell, Engineers, and according to a plat of Property of N. Q. Cline and Marth A. Cline, made March 12, 1955, by Pickell and Pickell, Engineers, being shown as Lot No. A on said plat and having the following metes and bounds, to-wit:

Beginning at an iron pin on the southeasterly side of Avice Dale Drive, joint front corner of Lots A and B and running thence S. 58-40 E. 206.5 feet to an iron pin, joint rear corner of Lots A and B; thence N. 35-31 E. 96 feet to an iron pin; thence N. 47-44 W. 214 feet to an iron pin on the southeasterly side of Avice Dale Drive; thence along the southeasterly side of Avice Dale Drive, S. 32-23 W. 136 feet to an iron pin, the point of beginning.
