State of South Carolina:

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the northeastern side of West Drive, near Travelers Rest, in Greenville County, South Carolina, being shown as the southeasternmost one/half of Lot No. 11 on a plat of COLEMAN HEIGHTS, made by Terry T. Dill, Surveyor, dated February, 1958, recorded in the RMC Office for Greenville County, S. C., in Plat Book RR, page 115, and having according to a more recent plat thereof made by James R. Freeland, P.E., dated July 28, 1977, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of West Drive at the joint front corners of Lots Nos. 10 and 11 and running thence with said side of West Drive, N. 38-30 W., 104.35 feet to an iron pin; thence a line through Lot No. 11 adjoining property now or formerly owned by Danny L. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided.
