NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Lynn Drive, being shown and designated as Lot No. 14 on plat of Rosewood Acres, prepared by Terry T. Dill, dated April 22, 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM at Page 154, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Lynn Drive at the joint front corner of Lots No. 14 and 15 and running thence with the common line of said lots N. 4-22 E. 205.5 feet to an iron pin; thence running S. 81-08 E. 100 feet to an iron pin at the joint rear corner of Lots 13 and 14; thence with the common line of said lots S. 4-15 W. 198.4 feet to an iron pin on the northern side of Lynn Drive; thence with the line of said drive N. 84-55 W. 100 feet to the point of beginning.
