Highway No. 146) and on the eastern side of Brown Drive near the City of Greenville, in the County of Greenville, State of South Carolina and shown as a 3.73 acre tract on plat entitled "Survey for Barbara Selvy" prepared by W. R. Williams, Jr., Engineer/Surveyor dated October, 1977, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in Brown Drive at its intersection with Woodruff Road (S. C. Highway No. 146) and running thence along Woodruff Road, S. 81-44 E., 358.2 feet to an old iron pin; running thence along the joint line of this tract and property now or formerly of Hazel H. Cofield, S. 4-05 W., 575 feet to an old iron pin in the line of property now or formerly of Paramount Developers, Inc.; running thence S. 62-00 W., 171 feet to an iron pin in the center of Brown Drive; running thence with the center of said drive N. 13-06-30 W., 418.6 feet to an iron pin; thence N. 12-48-30 W., 305.3 feet to an iron pin, point and place of beginning.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof.
