

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, on the northern side of Sunset Drive, being shown and designated as Lot No. 18 on Map 2 SUNSET HEIGHTS, made by C. O. Riddle, dated September 17, 1953, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Sunset Drive, joint front corner of Lots Nos. 17 and 18 and running thence with the joint line of said lots, N. 27-25 W. 200 feet to an iron pin; thence N. 62-35 E. 100 feet to an iron pin at the corner of Lots No. 19; thence with the joint line of Lots Nos. 18 and 19, S. 27-25 E. 200 feet to an iron pin on the northern side of Sunset Drive; thence with the northern side of said drive, S. 62-35 W. 100 feet to the point of beginning.
