to individually or collectively as "Tenants' leases", and that it will not do, or permit anything to be done, or omit and refrain from doing anything, the doing or omission of which will give any tenant a right to terminate any of said Tenants' leases or to abate the rental due thereunder.

Mortgagee may (but shall not be obligated to) take any action
Mortgagee deems necessary or desirable to prevent or cure any default
by Mortgagor in the performance of or compliance with any of
Mortgagor's covenants or obligations under any of said Tenants'
leases. Mortgagee may rely on any notice of default received from
any tenant any may act thereon as herein provided even though the
existence of such default or the nature thereof may be questioned or
denied by Mortgagor or any party acting on behalf of Mortgagor, and
such notice of default shall be conclusive evidence that a default
exists for the purpose of this paragraph.

Mortgagee shall have the right to enter upon the above described property and any other property owned or controlled by Mortgager which is affected by any of the terms, conditions, provisions, covenants and agreements of any of the Tenants' leases to such extent and as often as Mortgagee, in its sole discretion, deems necessary to desirable in order to prevent or cure any such default by Mortgagor. Mortgagee may expend such sums of money as Mortgagee, in its sole discretion deems necessary for any such purpose, and Mortgagor hereby agrees to pay to Mortgagee, immediately upon demand, all sums so expended by Mortgagee, together with interest thereon from the date of each such payment at eight and seven-eighths (8 7/8) per cent per annum. All sums so expended by Mortgagee, and the interest thereon shall be added to and secured by the lien of this instrument.
