"ALL that certain piece, purel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, consisting of approximately five (5) acres, more or less, being a portion of the property conveyed to the mortgagee herein by deed of Maria J. Siachos, recorded in the R.M.C. Office for Greenville County, S. C., in Deeds Book 809 at Page 303, and being more fully described according to a plat prepared for Cecil L.
