ALL ~~those~~ <sup>those</sup> certain parcels of land, with all improvements thereon, to wit: the certain parcel of land, being and being in the State of South Carolina, County of Greenville, on the northwest side of Catalina Drive (formerly

Arlington Street) near the City of Greenville in the Community of Paris, State and County aforesaid, the same consisting in the aggregate of 250 feet fronting the northwest side of Catalina Avenue, extending back on to a depth on the southerly side of 160 feet, extending on the northeast side to a depth of approximately 150 feet, and being 250 feet across the rear. The northeasternmost fifty foot portion of this tract is shown as a part of Lot 26, Block E, plat entitled "Paris Heights" recorded in the RMC Office for Greenville County, S.
