MORTGAGE OF REAL PROPERTY

THIS MORTGAGE made this 7th day of December among James Larry Webb & Ina Sue Webb (hereinafter referred to as Mortgagor) and FIRST EUNION MORTGAGE CORPORATION, a North Carolina Corporation (hereinafter referred to as Mortgagee):

(c) AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest * thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:

NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville _____ County, South Carolina:

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the eastern side of Meaway Court, in Austin Township, Greenville County, South Carolina, being shown and designated as Lot No. 89 on Plat of HOLLY TREE PLANTATION, PHASE I., Section I. made by Enwright Associates, Inc., Surveyors, dated May 28, 1973, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4-X at Page 37, reference to which is hereby craved for the metes and bounds, thereof.

THIS being the same property conveyed to the mortgagors herein by deed of Holly Tree Plantation, A Limited Partnership, dated July 21, 1977, recorded in the RMC Office forGreenville, S.C. in Deed Book 1060 at Page 983 on July 22, 1977.

THIS mortgage is second and junior in lien to that mortgage given to Fidelity Federal Savings & Loan in the original amount of \$54,400.00 recorded in RMC Office for Greenville, S.C. in Mortgage Book 1404 at Page 776 on July 22, 1977.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heaters (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple: that the premises are free and clear of all encumbrances except for a prior Mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the lawful claims of all persons whomsoever.

MORTGAGOR COVENANTS with Mortgagee, its heirs, successors and assigns as follows:

- 1. NOTE PAYMENTS. Mortgagor shall make timely payments of principal and interest on the above mentioned Note in the amounts, in the manner and at the place set forth therein. This Mortgage secures payment of said Note according to its terms, which are incorporated herein by reference.
- 2. TAXES. Mortgagor shall pay all taxes, charges and assessments which may become a lien upon the premises hereby conveyed before any penalty or interest accrues thereon and shall promptly deliver to Mortgagee (at its request) official receipts evidencing payment thereof. In the event of the passage after the date of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its successors and assigns, without notice become immediately due and payable.
