

2. That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagor, on the first day of January, until the sum due is fully paid, the following sums:

A. An amount sufficient to provide for the payment of taxes, assessments, insurance premiums, and other charges, including water rates, which may become due and payable during the year, and to be held by the Secretary of Housing and Urban Development prior to payment.

B. It and is agreed that, from time to time and at such times as the Mortgagor shall request, the Secretary of Housing and Urban Development shall cause to be made out in the name of the Mortgagor, and dated the annual or semi-annual tax statement, or other appropriate certificate, the amount of taxes, assessments, and insurance premiums due under the note, and to be paid to the Secretary of Housing and Urban Development pursuant to the National Housing Act, as amended, and applicable Regulations thereunder.

B. It and is agreed that, on the first day, and this instrument are valid, the Secretary of Housing and Urban Development shall charge in his account with the Mortgagor, each month, an amount equal to one-twelfth (1/12) of one-half (1/2) of one percentum of the average monthly balance due under the note, including advances and prepayments.

C. A sum equal to the amount stated above, plus the premium that will mature on the date of sale of the property and the hazards insuring the same, including property taxes and assessments, next due on the mortgaged property, all as estimated by the Mortgagor, less amounts already paid by him, deducted by the Mortgagor, but not by the Mortgagor, prior to the date when such amounts become payable, and such amounts will be considered as having been paid by the Mortgagor, in trust, for principal and rents, premiums, taxes, and other assessments, and

D. All assessments, taxes, or other charges, including, if this paragraph and all amounts to be paid under the same are unpaid, shall be added thereto and the amount so added shall be paid by the Mortgagor, in trust, as a single payment to be applied by the Mortgagor to the Mortgagor, items in the order set forth.

E. Premium, taxes, under the contract of insurance with the Secretary of Housing and Urban Development, and this charge of fees of the Mortgagor, shall be paid quarterly.

F. Taxes, special assessments, fire and other hazard insurance premiums.

G. Interest, if any, on unpaid principal.

H. Any deficiency in the amount paid with respect to any of the payments shall be made up by the Mortgagor, on the due date of the next subsequent payment, upon default in the previous payment. The Mortgagor, and the Mortgagor, shall pay to the Mortgagor, \$10.00 for each payment, or, if an interval of 15 days or more occurs, for the extra expense, and the like, in making such payments.

I. As the total of payments made by the Mortgagor under (b) of paragraph 2 preceding shall exceed the amount of payments actually made by the Mortgagor for taxes or assessments or insurance premiums, as the case may be, such excess, if the loan is current, at the option of the Mortgagor, shall be credited on subsequent payments to be made by the Mortgagor, or refunded to the Mortgagor. If however, the monthly payments made by the Mortgagor under (b) of paragraph 2 preceding shall not be sufficient to pay taxes and assessments and insurance premiums, when the same shall become due and payable, then the Mortgagor shall pay to the Mortgagor any amount necessary to make up the deficiency, on or before the date when payment of such taxes, assessments, or insurance premiums shall be due. If at any time the Mortgagor shall tender to the Mortgagor, in accordance with the provisions of the note secured hereby, full payment of the entire indebtedness represented thereby, the Mortgagor shall, in computing the amount of such indebtedness credit to the account of the Mortgagor all payments made under the provisions of (a) of paragraph 2 hereof which the Mortgagor has not become obligated to pay to the Secretary of Housing and Urban Development, and any balance remaining in the funds accumulated under the provisions of (b) of paragraph 2 hereof. If there shall be a default under any of the provisions of this mortgage resulting in a public sale of the premises covered hereby, or if the property is otherwise acquired after default, the Mortgagor shall apply, at the time of the commencement of such proceedings, or at the time the property is otherwise acquired, the balance then remaining in the funds accumulated under (b) of paragraph 2 preceding, as a credit against the amount of principal then remaining unpaid under the note secured hereby, and shall properly adjust any payments which shall have been made under (a) of paragraph 2.

J. That he will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impositions, for which provision has not been made hereinbefore, and if default thereof the Mortgagor may pay the same, and that he will promptly deliver the official receipts therefor to the Mortgagor. If the Mortgagor fails to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the Mortgagor may pay the same, and all sums so paid shall bear interest at the rate set forth in the note secured hereby, from the date of such advance and shall be secured by this mortgage.

K. That he will keep the premises in as good order and condition as they are now and will not commit or permit any waste thereof, reasonable wear and tear excepted.

L. That he will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagor against loss by fire and other hazards, casualties and contingencies in such amounts and for such periods as may be required by the Mortgagor, and will pay promptly, when due, any premiums on such insurance provision for payment of which has not been made hereinbefore. All insurance shall be carried in companies approved by the Mortgagor and the policies and renewals thereof shall be held by the Mortgagor and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagor. In event of loss Mortgagor will give immediate notice by mail to the Mortgagor, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagor instead of to the Mortgagor and Mortgagor jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagor at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all right, title and interest of the Mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.

M. That he hereby assigns all the rents, issues, and profits of the mortgaged premises from and after any default hereunder, and should legal proceedings be instituted pursuant to this instrument, then the Mortgagor shall have the right to have a receiver appointed of the rents, issues, and profits, who, after deducting all charges and expenses attending such proceedings and the execution of his trust as receiver, shall apply the residue of the rents, issues, and profits, toward the payment of the debt secured hereby.

N. That if the premises, or any part thereof, be condemned under any power of eminent domain, or acquired for a public use, the damages, proceeds, and the consideration for such acquisition, to the extent of the full amount of indebtedness upon this mortgage, and the note secured hereby remaining unpaid, are hereby assigned by the Mortgagor to the Mortgagor, and shall be paid forthwith to the Mortgagor to be applied by it on account of the indebtedness secured hereby, whether due or not.
