BEGINNING at an iron pin on the northerly side of Hillsborough Drive, said pin being the joint front corner of Lots 48 and 49 and running thence with the common line of said lots, N. 19-00 E. 180 feet to an iron pin on the joint rear corner of Lots 48 and 49; thence S. 71-00 E. 110 feet to an iron pin on the joint rear corner of Lots 49 and 50; thence with the common line of said lots S. 19-00 W. 180 feet to an iron pin on the northerly side of Hillsborough Drive; thence with the northerly side of Hillsborough Drive; thence with the northerly side of Hillsborough Drive N. 71-00 W. 110 feet to the corner of beginning.
