- Evans hereby confirms that the foregoing Mortgage shall secure (a) the Note of Evans to Mortgagee referred to above in the principal sum of \$500,000.00; (b) a certain Guaranty executed by Evans contemporaneously herewith and delivered to Mortgagee under which Evans guarantees all existing and future obligations and liabilities of National Icee Corporation and its wholly-owned subsidiary companies to Mortgagee; (c) all other existing and future liabilities of every kind of Evans to Mortgagee; and (d) all interest, costs and expenses, including reasonable attorneys' fees, accruing in connection with the foregoing obligations. Evans therefore agrees that Mortgagee may retain the Mortgage and enforce its rights and remedies thereunder until all liabilities described above of Evans to Mortgagee are paid and satisfied in full.
