MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, David W. Garner, Sr. and Patricia E. Garner

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

--- Twenty-seven Thousand Five Hundred Fifty and no/100ths (\$27,550.00--)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

--Two Hundred Twenty-one and 69/100ths 221.69

month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of soid debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor in the Mortgagor's occount, and also in consideration of the sum of Three Dollars (53(0)) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is bereby acknowledged, has granted, leargained, sold and released, and by those presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 212 on plat of Sherwood Forest, recorded in Plat Book GG, Pages 70 and 71, and having according to a more recent survey made December, 1955, by R. W. Dalton, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Nottingham Road at the joint front corner of Lots Nos. 211 and 212; running thence with the line of said lots S. 20-17 E. 160 feet to an iron pin; running thence S. 69-43 W. 75 feet to an iron pin in the line of Lot No. 214; running thence with the rear line of Lots Nos. 215 and 214 N. 20-17 W. 160 feet to an iron pin on the southeastern side of Nottingham Road; running thence with the southeastern side of Nottingham Road, N. 69-43 E. 75 feet to the point of beginning.
